Research Projects Currently in Process

<u>From Workplace to Families:</u> Fulfilling the Promise of Hochschild's Emotion Work System (2008-2009).

Dr. Howard Bahr and I initiated this exploratory study to test the applicability of occupational instruments to measure and evaluate emotion work done by mothers and fathers in the family setting. Previous research has not examined gender differences in family emotion work. The measures used have masked the measurement of felt emotion and perceptions of display rules as originally intended by Hochschild. As a result, emotion work done by both mothers and fathers has been unrecognized and misunderstood. A research proposal was submitted to the College of Family, Home and Social Sciences, Brigham Young University for 2008-2009. The project will involve focus groups, face-to-face interviews, and phone interviews with a sample of mothers and fathers in Utah County. Funded budget: \$6,040

The Changing Landscapes of Women Project:

This project is part of a larger, multi-state study on "The Changing Landscape of Women in America: Understanding Work, Family, and Personal Issues" (W-1167; MIN 52-018). This project was implemented with my graduate advisor, Dr. Kathy Rettig, at the University of Minnesota to: (a) determine the major challenges, concerns, satisfactions, and needs of a target group of *professionally employed mothers* that are related to work, family, and personal flourishing or fulfillment; (b) identify the media and information sources used and their perspectives on these sources, to resolve and/or confront these challenges; and (c) assess the extent to which these messages facilitate or inhibit the struggles to achieve healthy work, family, and personal lives. While at the University of Minnesota I participated in conducting 4 focus groups. The project has continued in Minnesota including 4 other focus groups.

The Community Engaged Parent Education Project:

This project is in its 3rd year and nearing completion. The project was implemented under the direction of Dr. William Doherty at the University of Minnesota in Early Childhood & Family Education classes throughout the state. Its purpose has been to help parents develop their capacity for reflection and civic action on public issues related to the well-being of children and families. The project was funded by the McKnight Foundation. I am currently coordinating and completing data analysis of the project and preparing manuscripts for publication that discuss this innovative project.
